
COMPLEX BUSINESS OFFER APPROVAL PROCESS

An approval process for comprehensive bids, which involve inputs from many units and sub-suppliers, can be definitely accelerated. However, is it also possible to increase certainty that the company makes only offers backed by sufficient resources and that financial risks are identified and controlled? Business Process Management (BPM) solution, managing the process across units, management levels and information systems, is the answer to these challenges.

A company delivers complex packaging products. Each business offer has to undergo an approval process, that ensures that all units (and subcontractors) involved in the contract will have sufficient resources. The offer has to be confirmed by technical director, sales manager and in some cases also the financial director (and many others). Also a crosscheck of data in some information systems will take place. Since each offer is individual and specific, also the nature of the approval process is very variable.

The speed determines in some cases whether the contract will be won or lost.

Requirements

- Accelerate the process.
- Reduce the vulnerability to errors and omissions.
- No decision-making person should be omitted during approval process.
- Improve coordination between offer preparation and resource planning (people, machines, components, cash flow...).
- Save time of the key salesmen (project manager) who till now have to personally track each case.

Solution

BPM solution is implemented above legacy information systems to execute processes across the company. A project manager sets the work flow including mandatory verification steps for each project. He can choose from number of default process blocks, combine or alternatively modify them. Finally he starts the workflow. Later he can follow the approval progress of individual offers in the graphical interface. Responsible managers can see namely what offers are currently being approved and what resource requirements follow from them.

Alternative solutions

Hire more employees and assign a project manager to each process instance. To develop a custom application might not be feasible because of the need to cover all the process variants.

Similar situations and processes


A similar solution can by applied on any important approval process that changes frequently and where it is unacceptable to omit a verification point, thus for example:

- Introduction of new products
- Marketing campaigns approval
- Purchase of expensive spare parts
